


# Vestal Festival 2026



**Saturday, June 6<sup>th</sup>**  
**10 a.m. - 3 p.m.**  
**Front Street**  
**Vestal**

All vendors will set up in their assigned space. Vendor site size is 10 feet wide by 10 feet deep. Exhibitors must provide their own table, chairs, canopy (not to exceed 10' x 10') and canopy weights. Homemade food & Flea Market/Garage sale items are not permitted. All vendors are subject to Town Board approval. Notification of site number and location will be mailed out to all vendors on May 15, 2026.

**\$25 to reserve a spot for 2026. (More than one spot can be reserved.)**

**\$50 for Food Trucks**

Checks must be made payable to: "Town of Vestal"

**All vendors must apply by Thursday, May 2, 2026, for approval.**

Submission of a Vendor Application form and/or participation in Vestal Festival is done at the sole and exclusive risk of the vendor/registrant. Application will be approved on a rolling basis.

# Vestal Festival 2026

**Saturday, June 6, 2026 10:00 a.m. – 3:00 p.m.**

1. Festival hours are 10:00 a.m. - 3:00 pm. Front Street will be closed beginning at 8:00 am. for vendor setup. Vehicle traffic, other than vendors, will not be permitted during these hours. All vendor vehicles must be off of the street by **9:30 am. You MUST commit to the entire day. Vehicles MUST enter Front Street from Main St., one-way traffic to Elizabeth St., for safety.**
2. Approved vendors will be assigned a space within the set boundaries on Front Street. Limited vendor space is available and all vendors must pre-register with the Town of Vestal Recreation Department. Spaces are allocated on a first-come, first-served basis through pre-registration. The Town reserves the right to limit vendors selling similar product to ensure diverse products to those attending the event. There is a \$25 cost for vendors this year. We will do our best to accommodate any requests, but there are **no guarantees**.
3. Booth size is 10 feet wide x 10 feet deep. Again, this year, all vendors will set up in the street. Vendors cannot exceed the 10-foot depth, so emergency vehicles are able to pass. **Canopy weights are required.**
4. **No** solicitors allowed other than vendors with booths. Merchants or residents who reside on the street may have a 10-foot-wide x 10-foot-deep space near their property, but must apply by May 2, 2026 or the space will be allocated to another vendor. (Please note that you reside on the street and where to better accommodate. Thank you.)
5. **No** bake sale or home-made food items, flea market items, lawn sales, garage sales, etc. allowed.
6. The Town of Vestal is not responsible for lost, stolen, damaged, etc....goods. Vendors must provide their own tables, chairs and canopy. Canopies must be freestanding. **Canopy weights are required.**
7. All vendors are required to have an ABC-type fire extinguisher. All food concessions, where cooking grease is present, are required to have a Type K extinguisher in addition to the required ABC-type fire extinguisher.”
8. **All food concessions must be approved and must pre-register. The number of food concessions is limited.** Cooking greases or coals cannot be dumped into Town containers and must be removed by the food vendor. **All food vendors must have a Broome County Health Department Permit, Proof of Insurance and Peddlers Permit from Town Clerk** (fee is waived for this event). **Bake Sale & Homemade food Items are prohibited.** Food vendors can come earlier to set up, to make arrangements contact Dulcie at: [dmalizia@vestalny.gov](mailto:dmalizia@vestalny.gov)
9. Vendors are not allowed to sell or have alcohol, smoke bombs, snappers, any type of explosives, or any type of firearms or they will be asked to leave the festival immediately.
10. The Town reserves the right to close the festival down if the weather poses a risk or any other “Acts of God” (fire, etc.)
11. Please respect our Town by policing your booth area at the end of the day. Help us make clean up easier. Thank you for your help.
12. The Town reserves the right to ask any vendors (craft or food) to leave the festival if the above rules are not met. • **Submission of a vendor application form and/or participation in Vestal Festival is done at the sole and exclusive risk of the vendor/registrant.**
